The 44th year of the New England Paddlesports Championship (NEPC) will welcome canoe, kayak, SUP, and surf ski racers from across the Northeast to compete for honors on New England's historic Connecticut River between southwest New Hampshire and southeast Vermont. Racers choose to run the 12-mile competitive course or a 5-mile recreation course. The course laps the Brattleboro-Hinsdale island by passing under the Rte. 119 bridges, where spectators cheer on competitors. NEPC is part of the New England Canoe and Kayak Racing Association (NECKRA) Flatwater Point Series.
